**BIHAR CINEMA (REGULATION) (AMENDMENT) RULES, 2011**

**1. Short name, extend and Commencement** – (i) These Rules may be called the Bihar Cinema (Regulation) (Amendment) Rules, 2011.

(ii) It shall extend to the whole of the State of Bihar.

(iii) It shall come into force at once.

**2. Amendment in Rule-3(ii) of Bihar Cinema (Regulation) Rules, 1974-** In the rule 3(ii) of the said Rules, after the word "Executive Engineer" the words "Public Works Department (Building)", shall be substituted by the words "Building Construction Department, suitable Person from Fire Brigade Office".

**3. Amendment in Rule-5 of Bihar Cinema (Regulation) Rules, 1974-** In the said Rules, Rule-5 shall be substituted by the following:-

"The Building plans of the proposed Cinema houses shall be approved technically by the Executive Engineer, Building Construction Department within two months from the date of its submission by the intending Cinema licencees. While approving the provisions of relevant Building-by-Laws should be strictly adhered to."

**4. Amendment in Rule-6 (i) of Bihar Cinema (Regulation) Rules, 1974-** In the Rule-6 (i) of the said Rules, the following words after "Cinema building applied for" shall be deleted- "With the permission of the State Government" and after the words the "licensing authority" the words- "or the State Government " shall be deleted.

**5. Amendment in Rule-7 of Bihar Cinema (Regulation) Rules, 1974-** In Rule-7 of the said Rules, the words "With the permission of the State Government" shall be deleted and the following lines shall be added after the words "Permission was granted":-

"In any case total period, after the permission of the construction of permanent Cinema buildings, will not exceed three years without the permission of the State Government."

**6. Amendment in Rule- 8 of Bihar Cinema (Regulation) Rules, 1974-** (1) In the Rule- 8 (i), of the said Rules, the words "Subject to the approval of the State Government" after the words "the licensing authority may" shall be deleted.

(2) The third proviso of the above said rule will be substituted by following:-

"Provided further that all such permanent licence shall be renewed by the licensing authority without obtaining approval of the State Government. The proposal received shall be put up before the licensing authority within one month from the date of receipt of application the receipt of which shall be given to applicant and the licensing authority shall pass reasoned order within next one month failing which the renewal of the licence shall be deemed as having been approved".

**(3) The following fourth proviso shall be added to Rule 8 (i):-**

"Provided further that the application for such extension should also include an affidavit duly sworn in indicating that the licensee has not violated any of the provisions of these Rules and direction of the Government."

**(4) A new sub-rule (ii) shall be added.-**

"(ii) In any case the licensing authority shall grant the licence within a period not exceeding three months or refuse the licence with a reasoned order. If no communication is received from the licensing authority within the prescribed period of three months, the licence would be deemed to be automatically granted."

**7. Amendment in Rule-10 of Bihar Cinema (Regulation) Rules, 1974 –** In the said Rules in Rule-10, the following proviso shall be added at the end:-

"Provided that the aforesaid fee structure can be reviewed and amended by the State Government from time to time by issuing suitable notification."

**8. Amendment in Rule-12(i)(a) & 12(i)(b) of Bihar Cinema (Regulation) Rules, 1974-**(1) In the first line of Rule-12(i)(a) of the said Rules, the words " or on the directions of the state Government" shall be deleted.

(2) In the last line Rule12(i)(a) of the said Rules the word "Film Division Certificate" Shall be deleted.

(3) In the first line Rule12(i)(b) of the said Rules, the word "Cinema Inspector" shall be substituted by the word "officer designated by District Magistrate" and the word after the word "submit", "their" shall be substituted by the word "his".

**9. Amendment in Rule-13 (a) and 13(b) of Bihar Cinema (Regulation) Rules, 1974-**

(1) In the said Rules in Rule 13(a) the words "with the approval of the State Government" shall be deleted and the word "permanent" after the word "of film in a" shall be deleted.

(2) In the said Rules in Rule 13(b) the words "with the approval of the State Government" shall be deleted.

(3) The following provisos shall be added to Rule 13(b) of the said Rules:-

"Provided that the application for extension should be submitted within the expiry of period of one year".

(4) A new sub-rule 13 (bb) shall be added as following:-

"(bb) If the application for extension of licence is received, a proper receipt will be given to applicant and it shall be put up before the licensing authority within ten (10) days from the date of receipt of the application. The licensing authority shall extend the temporary licence, or refuse the same with a reasoned order within next fifteen (15) days, and if the licensing authority fails to do so within such period, the same shall be treated as extended."

Provided that the application for such extension shall accompanied with an affidavit duly sworn indicating that the licensee has not violated any of the provisions of these rules and direction of the Government".

**10. Amendment in Rule-14 of Bihar Cinema (Regulation) Rules, 1974 -**

(1) In sub-clause (a) of the first proviso of Rule-14 the word "three months" shall be substituted by the words, "six months".

(2) The following second proviso shall be added to Rule-14.

"Provided further that the film to be exhibited should be a cinematograph film of 35mm.

2. This notification shall come to force at once.
